4. PUBLIC COMMENT

5. MAYOR, COUNCIL, AND COMMITTEE COMMENTS AND REPORTS

a. Police, Traffic and Public Safety Committee - CM Gathercole

The committee will meet on Wednesday at 7:30 p.m. CM Gathercole asked Chief Coleman for an update on Genoptic regarding stop sign cameras. He reported that Obvio proactively installed "do not enter" cameras and will provide data analysis on violations during restricted hours, as well as some pedestrian data. This information should be available for the January meeting. The town attorney will meet with Obvio on December 2nd at 2:00 p.m. to finalize the agreement.

b. Sustainability Committee – CM Dubayah

The committee will meet tomorrow at 7:30 p.m.

c. Policy, Rules and Municipal Structure Committee - CM Godfrey

The committee met and got through some draft rules of procedure. There is still more work to do before presenting to Council, which is expected next year.

d. Public Facilities Committee - CM Sweet

The committee discussed the budget for Town Hall and strategies for moving forward. The next meeting is December 18.

e. Holiday Tree Lighting - Mayor Morrissey

The holiday tree lighting ceremony is scheduled for Saturday evening at 6:00 p.m. A special visitor from the North Pole will attend, and there will be refreshments.

f. Development Overview Committee - CM McGaughey

The committee will meet on December 11 to continue discussing Senate Bill 891. They will also begin tracking the Gilbert Woods development project, which is proposing townhouses between College Heights Estates and the University of Maryland.

6. NEW BUSINESS

a. Consideration of Reestablishing a Town Hall Construction and Design Budget Line Item

Motion: To introduce LR25-O-09 to re-establish reserve designated line-item 6650-08 Town Hall Construction Design and transfer \$454,047 from the unreserved, undesignated funds, and to establish public works capital outlay expense line item 65-3505 Stormwater Management Design and Engineering for expenditures, including transfers from the reserve designated line item 6655-08 for stormwater management design and engineering. *Motion made by CM Sweet, seconded by CM Kelby.*

b. Approval of Contract with ADP to Enter into a Payroll Service Agreement

Town Administrator Sandlin explained that ADP was unwilling to use the Town's standard contract template, which is why their contract requires review by the Town Attorney.

Item Title: Adoption of 25-CR-01 to Amend the Town Charter Section 618(b) to Delete the Requirement that the Newsletter Editor be Appointed by the Mayor and Approved by Council and Serve at the Pleasure of the Mayor and Council

Background/Justification:

- The newsletter editor is currently a contract position required by Charter section 618(b) to be appointed by the Mayor and approved by the Council and to serve at the pleasure of the Mayor and Council.
- The current Newsletter Editors notified Mayor Morrissey and Town Administrator Sandlin that they will conclude their service after the December edition of the newsletter is published.
- Effective December 6, 2025, the Council has determined that management and publication responsibilities for the monthly newsletter will begin transition to Town staff.
- Because the position will be filled by an individual that is not a department head, pursuant to Section 401(b) of the Charter the Town Administrator will appoint and remove, with notice to the Mayor, the employee(s) that will manage and publish the newsletter.
- As a result, oversight and management of the newsletter will be an administrative function under the Town Administrator.
- To enable the transition, the Charter should be amended to delete the requirement

Options/Alternatives:

Approve the proposed changes to the Charter

Approve a different process for publication of the Town newsletter

Make no changes in the Charter.

Fiscal Impact: Compensation for the Town employee responsible for publication and distribution of the newsletter is allocated within the FY 2026 budget. Printing costs will continue as before.

Committee Recommendation: The Policy, Rules & Municipal Structures Committee recommends amending Section 618(b) of the Town Charter to delete the requirement that the newsletter editor be appointed by the Mayor and approved by Council and serve at the pleasure of the Mayor and Council

CHARTER RESOLUTION 25-CR-01

Charter Resolution of the Mayor and Common Council of University Park, pursuant to the authority of Article XI-E of the Constitution of Maryland and §4-301 *et seq.* of Local Government Article, Annotated Code of Maryland, as amended, to amend the Charter of the Town of University Park, by repealing and re-enacting Article VI, “Finance”, Section 618, "Purchasing and Contracts" of the Charter to delete the Town Newsletter Editor as a professional service position to be appointed by the Mayor and approved by the Council and to serve at the pleasure of the Mayor and Council.

Section 1: Be it resolved and ordained by the Mayor and Common Council of University Park that Article VI, “Finance”, Section 618, "Purchasing and Contracts" of the Charter of the Town of University Park be repealed, re-enacted and amended to read as follows:

Section 618. Purchasing and Contracts

(a) Purchases for the Town government shall be made by the Treasurer under the direction of the Mayor and Common Council. The Common Council may establish by Ordinance, rules and regulations regarding purchasing procedures including the use of competitive bids.

(b) All contracts involving professional services such as accounting, architecture, auditing, engineering, law, planning, ~~[Town newsletter editor]~~ and surveying shall be negotiated by the Mayor and approved by the Common Council. ~~[The newsletter editor shall serve at the pleasure of the Mayor and Council.]~~

Section 2: Be it further resolved that this resolution is adopted after at least 21 days of prior public notice of the public hearing and shall become effective fifty days after enactment by the Mayor and Common Council of University Park, unless petitioned to referendum in a manner prescribed by

Section 3: Be it further resolved that a complete and exact copy of this proposed Charter amendment shall be posted on the entrance door of the Town Hall of University Park, 6724 Baltimore Avenue, University Park, Maryland, for a period of not less than forty (40) days, and a fair summary of this Charter amendment shall be published at least four times on four successive weeks within that forty day period in a newspaper having general circulation in the Town.

Meeting Date: January 5, 2026

Item Title: Adoption of 25-O-09 to amend the FY 2026 Budget Ordinance Legislative Resolution 25-O-03, to reestablish Reserve Designated line item 6650-08, Town Hall Construction and Design and for the transfer of \$454,047.00 from Unreserved Undesignated Funds to that line item.

Background/Justification:

- The Town Council previously approved a dedicated Town Hall Construction and Design budget line item as part of the FY25 adopted budget.
- The Council authorized \$454,047 in the FY 2025 budget to support design and construction activities for the new Town Hall.
- During the FY26 budget process, this line item was inadvertently removed, shifting funds from the from a Reserved-Designated line item to the Unreserved/Undesignated line item.
- A re-establishment of the Town Hall Construction and Design Reserve-Designated line item is needed, along with an allocation of \$454,047 to that line item from the Undesignated Unreserved line item.

Options/Alternatives:

Approve or deny the proposed amendments to the FY26 budget.

Fiscal Impact: None. Funds are already in the budget but not properly allocated
