*WHEREAS*, the Town of University Park was incorporated in 1936 and is a small municipality of 924 single-family homes and nonetheless provides a full array of excellent services to its residents; and

*WHEREAS*, the Town of University Park maintains municipal streets, sidewalks, playgrounds and parks; is responsible for all sanitation, yard waste and compost collection, leaf vacuuming, and snow removal, and has a dedicated Police Department; and

*WHEREAS*, the Town values environmental sustainability and resiliency which is demonstrated by services like the compost program and the Shuttle Bus, and participation in Tree City USA, Maryland Smart Energy Communities and Sustainable Maryland; and

*WHEREAS*, in an effort to educate citizens about the role of municipal government and the importance of their participation in it, the Town of University Park is proud to promote municipal government awareness.

***NOW, THEREFORE, BE IT PROCLAIMED*** by Mayor and Council that the Town of University Park joins the Maryland Municipal League in declaring for University Park that November is Municipal Government Works Month.
