

Ordinance to Amend the Fiscal Year 2023 Budget

**LEGISLATIVE RESOLUTION 22-O-06**

Resolution and Ordinance of the Town of University Park, to amend the FY 2023 Budget Ordinance, Legislative Resolution 22-O-04, to transfer \$36,089.00 from line item G36 "ARPA Expenditures FY22" to line item G33 "Premium Pay - ARPA" to increase premium payments to Town employees from \$1.25 per hour to \$2.50 per hour through December 31, 2022, with premium payments to return to \$1.25 per hour beginning January 1, 2023.

Section 1: Be it resolved and ordained by the Mayor and Common Council of the Town of University Park that Legislative Resolution 22-O-04, Fiscal Year 2023 Budget Ordinance, be and is hereby amended to:

Transfer \$36,089.00 from line item G36 "ARPA Expenditures FY22" to line item G33 "Premium Pay - ARPA"

Section 2. Be it further resolved that this Ordinance shall become effective on July 1, 2022.

Section 3. If any section, subsection, provision, sentence, clause, phrase or word of this Ordinance is for any reason held to be illegal or otherwise invalid by any court of competent jurisdiction, such invalidity shall be severable, and shall not affect or impair any remaining section, subsection, provision, sentence, clause, phrase or word included within this Ordinance, it being the intent of the Town that the remainder of the Ordinance shall be and shall remain in full force and effect, valid and enforceable.




