EMERGENCY LEGISLATIVE RESOLUTION 23-O-05

EMERGENCY RESOLUTION AND ORDINANCE OF THE TOWN OF UNIVERSITY PARK, TO AMEND THE FY 2023 BUDGET ORDINANCE, LEGISLATIVE RESOLUTION 22-O-04, TO TRANSFER \$270,000 FROM GENERAL FUND/UNRESERVED FUNDS TO THE A/C 7049-00 RESERVES - STREET WORK PROJECT LINE ITEM IN THE CAPITAL IMPROVEMENT PROJECT FUND AND ALLOCATE \$270,000 TO THE A/C 7111-00 CONSTRUCTION - NZI EXPENSE LINE ITEM IN THE CAPITAL IMPROVEMENT PROJECT FUND

Section 1: Be it resolved and ordained by the Mayor and Common Council of the Town of University Park that Legislative Resolution 22-O-04, Fiscal Year 2023 Budget Ordinance, be and is hereby amended to:

Transfer \$270,000 from the General Fund/Unreserved Funds line item to A/C 7049-00 Reserves - Street Work Project line item in the Capital Improvement Project Fund and allocate \$270,000 to A/C 7111-00 Construction - NZI expense line item in the Capital Improvement Project Fund.

Section 2. Be it further resolved that this Ordinance shall become effective immediately as emergency legislation upon enactment by four members of Common Council of University Park.

Section 3. If any section, subsection, provision, sentence, clause, phrase or word of this Ordinance is for any reason held to be illegal or otherwise invalid by any court of competent jurisdiction, such invalidity shall be severable, and shall not affect or impair any remaining section, subsection, provision, sentence, clause, phrase or word included within



this Ordinance, it being the intent of the Town that the remainder of the Ordinance shall be and shall remain in full force and effect, valid and enforceable.


