Residents wishing to run as a candidate must:

1. Be at least 25 years of age,
2. Have resided in the Town at least 2 years prior to the election, and
3. Be a qualified and registered voter in the Town

Both forms must be completed and submitted before an individual may qualify as a candidate. Monday, April 7 by 5:00 p.m. to file as a candidate.
